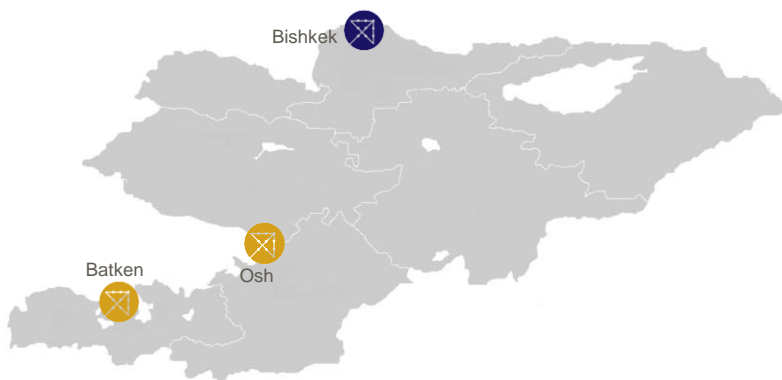

## Regional Programmes

### Silk Road CBT Initiative & Sustainable Energy for Tourism (Jan 2020 – July 2023)

This programme aims to boost the **competitiveness and sustainability of Community Based Tourism (CBT)** by empowering Business Associations, CBT MSMEs and other champions to promote **green tourism and Central Asia as one tourism destination**.

### Effective Governance & Economic Development (Jun 2021 – Oct 2025)

The project enhances **civil society engagement** and contribution to governance processes in particular **economic policy delivery**, accountability, and transparency on selected reform priorities. It promotes evidence-based and inclusive economic development while adapting to a changing social and political environment.

### Protection of Women at Risk and Survivors of Domestic Violence (Sep 2021 – Sep 2024)

The project strengthens **the role of civil society in addressing gender-based violence** and promoting the protection and empowerment of women at risk or **survivors of domestic violence**. It aims to identify gaps in implementation of national legislation, build the capacity of civil society organisations and raise society's awareness about existing harmful gender norms.

### STREAM (Aug 2022 – Aug 2025)

STREAM works with communities and stakeholders in the Ferghana valley to improve the **sustainable use of water and land resources** in riparian communities. With initial funding from USAID and drawing on the AGORA, GOCA and THRIVE flagships, STREAM is now in the inception phase and preparing a comprehensive analysis, with a focus on the impact of climate stresses, to foster an integrated and **evidence-based participatory approach** to Natural Resource Management.

### Displacement due to Conflict (Sep – Oct 2022)

This **rapid response** provided targeted support in Batken Province following the 2022 Kyrgyz-Tajik border conflict. 531 acutely affected households received **unconditional multi-purpose cash assistance** to use as they saw best in difficult times, benefitting 2,546 individuals in total.
