I. SUPPORT TO CSO'S (CIVIL SOCIETY ORGANIZATIONS) IN THE LIBYAN MUNICIPALITIES	
Background	<p>The present project will aim in particular at assisting civil society actors operating in the target municipalities to build their capacities and support the development of community-stabilization projects. Thus, the overall objective of the present action is to empower civil society actors in small and medium-sized municipalities on the migration routes in Libya so they are able to actively participate in local economic and social development efforts. The specific objective is to build the capacities of CSOs located on the targeted municipalities to enhance the impact of their work and better collaborate with LAs to address local needs and promote the inclusion of vulnerable groups in local development efforts</p> <p>Interventions within the framework of this project will be implemented over the period of 2 calendar years and 4 months (28 months) starting on 01/11/2017 and ending on 28/02/2020.</p> <p>Specific Objective: To support CSO's (civil society organizations) in Libyan Municipalities.</p> <p>Area of Intervention: Janzour, Zintan, Sharqya, Wadi Bawanees, Ghadames, Janzour, Garaboulli, Al Andalus, Emsallata, Zliten, Tarhouni, Jado, Jufra, Shwerif, Idri Shati</p>
Objectives	<p>The website development agency is a local Libyan consultant providing its service to ACTED for the designing and maintenance of an online platform aiming at facilitating knowledge sharing and cooperation among civil society organizations operating in the target municipalities.</p>
Scope of the work	<p>Design and maintain an online platform for maximizing cooperation and knowledge sharing among CSOs in the target municipalities. The online platform must be accessible to CSOs operating in all the target municipalities for knowledge sharing according to the requirements specified in the key deliverables.</p>

The Forum discussion section will be divided in sub/groups according to the following thematic areas: migration, gender, education, youth, inclusion of people with disabilities, displacement, socio-economic development, peace building, protection and human rights • <u>News section</u> – posting of events and initiative carried out by the CSO's

Web hosting after the end of contract. At the end of the contract (28/02/2020) the server will be moved to another one indicated by ACTED or the provider will keep the portal life and give access to ACTED to the host and the monthly back up.</p> <p>6. Training CSOs</p> <ul style="list-style-type: none"> • Provide to 45 CSOs 1 day training on the usage of the platform and social media according to the following geographical division: <ul style="list-style-type: none"> - Greater Tripoli area/West (Hay Handalus, Garaboulli, Janzour, Tarhouna, Zliten, Msallata) - Nefusa Mountain/centre (Nalut, Jado, Zintan) - South (Sharqya, Wadi Bawanees, Idri Shati, Jufra, Shwerif, Ghadames)
Timeframe	5 weeks for the design and development of the platform 6 weeks for the delivery of the trainings
Location	The web platform must be accessible in all region of Libya (West, East and South)
