2. Date of delivery: Within 21 celendar days after signing the contract.

3. Validity of the offer: Recommended 3 months

The answers to this tender should include the following elements:

- A written quotation including all the product specifications, the price per unit, quantity proposed and unit, and total price:
- ➤ A sample of the product;
- A certificate of origin.
- > The ID of the legal representative of the company.

GENERAL CONDITIONS:

- 1. The closing date is on 31/07/2019 at 01:30 PM, all documents to be submitted to ACTED office at the following address: Gaza city seaport area, Haboosh Street, Hijji Building- 4th Floor.
- 2. Bidders can apply for one lot or more, depending on their ability and legal registration.
- 3. Tenderers will fill, sign, stamp and return part A (instruction to bidders), part B (Offer form), part C (bidder's questionnaire), part D (Ethical declaration & checklist) and part E (Particular conditions) according to ACTED's formats.
- 4. Tenderers will sign and return all pages of the Product Specifications for which they apply.
- 5. Bidders must have a bank account at an authorized bank from the Palestinian Monetary Authority.
- 6. All prices should be in USD, as it shall exclude VAT.
- 7. The offer to the call for tender will not result in the award of a contract.
- 8. The offer must be submitted to ACTED logistics department in a sealed envelope with the mention "T/12DSF/I62-NFI/Gaza/16-07-2019, not to be opened before 31/07/2019".



- 9. Unsealed envelope and late offers will not be considered.
- 10. Eligible companies should be able to provide ACTED with Zero VAT invoice and a non-deduction from the source.
- 11. ACTED has the right to cancel, postpone, or extend the tender.
- 12. ACTED has the right to increase or decrease the tender total quantites by 25%.
- 13. ACTED has the right to split out the tender between two or more suppliers.
- 14. Eligible companies need to provide a bank guarantee or bank cheque of 10,000.00 USD for tender entry, valid for 90 days starting from the tender closing date, where personal cheques or cash will not be accepted.
- 15. All Kits should be delivered within 21 calendar days after the contract signature.
- 16. Fees of tender advertising in newspapers and websites will be charged to the winner bidder.
- 17. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all contract offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. To this end, ACTED reserves the right to carry out anti-terrorism checks on contractor, its board members, staff, volunteers, consultants, financial service providers and sub-contractor.
