- 3. Validity of the offer: Minimum 1 month after the date of the submission of the offer.

The answers to this tender should include the following elements:

A written quotation including the total price including all charges (the total price should include all out-of-pocket expenses including airfares, meals, lodging and any other incidentals costs) to perform the audit



assignement and submit the audit report. Bidders should present their offers in the Offer Form format provided by ACTED;

- Prices should be in Euros or US Dollars Inclusive applicable taxes;
- Copies of the ID or passport of legal representative and a Copy of Company registration documents and license;
- A technical offer including:
  - a. Organogram of the team structure and CV(s) of the auditors deployed;
  - b. A detailed methodology and work plan including estimated number of staff/days per auditors deployed;
  - c. Proof of experience in specialized audits in complaince with US government requirements (such as 2 FCR 200, Uniform Administrative Requirements, Cost Principles and Audit Requirements);
  - d. Proof of experience and knowledge of the USAID Automated Directives System;
  - e. Proof of experience and knowledge of the 2 CFR 200 Subpart F on audit and 2 CFR 700 on Cost Principles;
  - f. Proof that the independant audit firm is part of the up-to-date USAID List of Audit Firms
  - g. Bidders are encouraged to annex additional documentations/pictures as required.
