- d. Bank account reference must be completed (Compulsory)
- **e. Annex 2.** Filled in English with all the information mentioned in the document or reference to the offer and signed **(Compulsory).**
- **f. Benefits table** (sickness, maternity, hospitalization) for year 2022 (asked in annex 2) (Compulsory).
- **g.** Instructions to Bidders is attached, filled, signed and stamped at least on last page by the supplier. **(compulsory)**
- h. Bidder's questionnaire (Compulsory).
- i. Bidder's ethical declaration (Compulsory).
- j. Bidder's check list (Compulsory).
- k. General condition of purchase (Compulsory).
