- 4. Unsealed envelopes and late offers will not be considered.
- 5. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. To this end, ACTED reserves the right to carry out anti-terrorism checks on any contractor, its board members, staff, volunteers, consultants, financial service providers and sub-contractors.

Minutes of this session will then be shared to all bidders who attended the visit.

A visit to the site of Causeni Community Center (lot 2) is organized on the 17/02/2023 at 10pm at the following address: Cauşeni, Str. Alexei Mateevici 7. This visit is mandatory in order to be allowed to bid for the lot 2. In case supplier does not attend, the offer submitted for lot 1 will be declared ineligible. The visit will be followed by a Questions & Answers session, where all suppliers are welcome to ask any question related to this Call for Tender. Minutes of this session will then be shared to all bidders who attended the visit.





- 9. Lots1:
 - The Bidder may bid for one or all Lots. Each lot may be subject to a separate contract and the quantities indicated for the different lots cannot be divided. The Bidder must offer all items & quantities indicated for each lot. Bids for part of a lot only will not be considered.
