1. Description: Rehabilitation of community center

2. Product class / category: Works

3. Quantity/unit: 1 Community Center to rehabilitate

RESPONSIBILITIES OF THE SUPPLIER:

1. Place of the works: Ungheni

Maximum date of delivery:2 months after the beginning of the works

3. Minimum offer validity period required: 1 month

- 4. Unsealed envelopes and late offers will not be considered.
- 5.
