Through this tender ACTED is requesting a company to provide detailed written offers for the supply of the following products:

PRODUCT SPECIFICATIONS:

1. Description: Works for RAC UID 12 Chişinău rehabilitation

2. Product class / category: Works

3. Quantity/unit: 1 Refugee accommodation center

RESPONSIBILITIES OF THE SUPPLIER:

1. Place of the works: Chişinău

2. Maximum date of delivery: 15 of December 2023

3. Minimum offer validity period required: 3 months min; ideally 6 months

- 3. The offer must be submitted to ACTED Logistics department in a sealed envelope marked "Not to be opened before 09/10/2023" and the Tender reference number above. - **4.** Unsealed envelopes and late offers will not be considered.
- 5. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy.
