

CALL FOR PREQUALIFICATION ACTED Moldova Instructions to Applicants

Through this call for prequalification ACTED is requesting a company to provide written applications for the supply of the following small repair works: *plumbing maintenance work, electrician maintenance work, general building maintenance work and so on.*

PROJECT BACKGROUND

Under this project, ACTED are responsible for maintaining in good shape a dozen Refugee Accommodation Centers (RAC) across Moldova. On a regular basis, small repairs need to be done quickly in the RACs. ACTED are here running a prequalification round to build a pool of suppliers who could perform those repairs. For each repair, ACTED will then run a competition procedure between suppliers who are in the pool.

PRODUCTS DESCRIPTION & OVERALL TECHNICAL SPECIFICATIONS

Small repairs consist in plumbing maintenance work (fixing leaks, boilers, repairing toilets, filters, etc), electrician maintenance work (installing power sockets, fixing lighting issues, maintaining an electrical installation, etc), general building maintenance work (changing windows, repairing damages on walls, doors, floors, etc) and so on. The lists of works described in this document are not exhaustive.

DELIVERY TIMELINE

Depending on the emergency of the repairs, the works will need to be conducted within a matter of hours to a few weeks.

DELIVERY LOCATION

Works will take place in buildings hosting between 10 to 150 people. These buildings are located all across Moldova.

The responses to this call for prequalification shall include the following elements:

2	An original Application Form (PRO-06.6) dated, filled, signed & stamped by the Bidder with all financial, human and technical elements required in annex
3	Any other compulsory item specified in the Applicant's Checklist (PRO-06.7)
4	Last 2 years financial statements
5	Safety Plan (for works)
6	List of staff including engineers / supervisors
7	Evidence of similar past experience with others NGO, institution, private companiesetc
8	The Applicant's Checklist (PRO-06.7) dated, filled, signed & stamped by the Bidder

It is important to note that all documents must be filled, dated, signed & stamped by the Applicants in order to be considered as eligible. ACTED only accepts bids that have been filled in in either English or French.





GENERAL CONDITIONS:

- 2. The submission of an application by an applicant to this call for prequalification may not result in the award of a contract.

The application must be submitted to ACTED Logistics department in a sealed envelope marked "Not to be opened before 04/03/2024" and the Prequalification reference number above. If the offer is sent by email, it must state in the object "Offer for prequalification P/67FUN/G4Z/DRA/MRA/CHS/PROG/19-02-2024"

- 3. Unsealed envelope and late applications will not be considered.
- 4. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all applications are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. To this end, ACTED reserves the right to carry out anti-terrorism checks on any contractor, its board members, staff, volunteers, consultants, financial service providers and sub-contractors.
- 5. Collusive practices are prohibited and will lead to applications rejection.
- 6. ACTED adopts a zero tolerance approach towards corruption and is committed to respecting the highest standards in terms of efficiency, responsibility and transparency in its activities.
