- 2. The submission of an offer by a bidder to this call for tender may not result in the award of a contract.
- 3. The offer must be submitted to ACTED Logistics department in a sealed envelope marked "Not to be opened before 25/03/2024" and the Tender reference number above. - 4. Unsealed envelopes and late offers will not be considered.
- 5. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. To this end, ACTED reserves the right to carry out anti-terrorism checks on any contractor, its board members, staff, volunteers, consultants, financial service providers and sub-contractors.
- 6. Collusive practices are prohibited and will lead to offers rejection.
- 7. ACTED adopts a zero tolerance approach towards corruption and is committed to respecting the highest standards in terms of efficiency, responsibility and transparency in its activities. - 8. A visit to the site of RAC UID 12 Chişinău (lot 1) at the following address: str. Valea Rediului 16, will be organized on the 11<sup>th</sup> of March. This visit is mandatory. In case supplier does not attend, the offer submitted for lot 1 will be declared ineligible. The visit will be followed by a Questions & Answers session, where all suppliers are welcome to ask any question related to this Call for Tender. Minutes of this session will then be shared to all bidders who attended the visit.
- 9. All expenses related to the site visit are the sole responsibility of the bidder.
- **10.** If a non-Moldovan company intends to participate to the call for tender, it must prior ensure to comply with all national regulations in terms of works (visa, governmental authorization, works permits, etc...). All related expenses will be their sole responsibility. Acted reserves the right to reject a non-Moldovan bidder who wouldn't have such authorizations.
- **11.** All tenders must be signed in manuscript. Tenders signed electronically will not be considered.
- **12.** The work must be carried out entirely by the supplier. The use of contractors is strictly forbidden.
- **13.** Rehabilitation must comply fully with the elements mentioned in the offer form, as well as the information on the plan in appendix 1 of this call for tender.
- **14.** Lots<sup>1</sup>:
  - The Bidder must offer all items & quantities indicated for the lot. Bids for part of the lot only will not be considered.
