- 7. Unsealed envelope and late offers will not be considered.
- 8. Applicants should be submitting their detailed quotations/proposals in English. All prices to be in Sri Lanka Rupees, including tax if applicable (tax figures maximum after the decimal point)
- 9. Specific/payment terms and conditions should be clearly mentioned
- 10. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. SPECIAL CONDITIONS:

Supplier Must,

- Have the capacity to deliver the complete package of services including supply of equipment/materials, installation & commissioning, and post installation back up support.
- b. Be registered at the Sri Lanka Sustainable Energy Authority to engage in Solar PV Roof Top installation in Sri Lanka.
- c. Have minimum of one Graduate Engineer (with minimum of 02 years of industrial experience or Diploma in Electrical/Mechanical Engineering at NVQ 6 level with 05 years of industrial experience of which 01 year in the solar industry) and Minimum of 02 Technician (with NVQ 4 or NVQ 3 level or equivalent qualifications and with 02 years of industrial experience).
- d. Complete the PRO-06 Offer Form or confirm in writing that the proposal meets the required specification, or, if there are changes to the specification, the supplier must provide details of what the changes in specification are. This document must be signed and stamped by supplier.
- e. Indicate the prices in the Offer Form in LKR.
- f. Provide the company's technical brochure, which exactly matches the required equipment, and that contains a complete specification supporting the supplier's document. The technical brochure must be signed and stamped by the supplier and submitted with the tender.
- g. Provide equipment only in Brand New condition. If damage or cracks occur during delivery, if found after delivery, the equipment will be cancelled or returned.
- h. Install the equipment within 15 days from the date of delivery and carry out necessary tests after installation. If there are any special requirements for installation, these shall be clearly stated in the tender. Brochures or manuals supplied with the equipment shall be in English.
- i. The supplier should deliver the equipment only from 09.00am to 03.00pm in weekdays only.
- j. Indicate the cost of the equipment including delivery, installation, testing and commissioning, and all applicable taxes.
- k. Submit for payment an invoice for the all-inclusive price, i.e. without tax invoice or commercial invoice, as Acted is obliged to pay VAT. Payment by Acted will be made within 14 days from the date of invoice. However, if Acted receives the invoice before completing the installation, testing and commissioning - the payment will be proceeded within 14 days from the test run completed.
- I. Mention free services and maintenance of the equipment in the tender.
- m. Notify the delivery date to Acted in 05 days (flexible schedule) to make the necessary arrangements.
