In 2024, Acted supported more than 18 million people in 43 count les, thanks to the commitment of its 6,836 employees and the support of thousands of partners. With a budget of more than 578 million euros, 528 projects were implemented to respond to emergencies, ensure resilience and open up sustainable prospects.

For more than 30 years, Acted has been working at the forefront of humanitarian action, to save lives, meet the essential needs of crisis-affected populations and build a more sustainable future. In the face of increasing humanitarian needs, accentuated by the climate crisis, Acted pursues a triple mandate: humanitarian aid, environmental action and sustainable development.

Our compass: «Think local, act global». This approach encourages us to anchor every action in a detailed understanding of the local area, drawing on local knowledge, capabilities and dynamics. It is this grassroots intelligence that feeds our global response and fuels our commitment to a 3ZERO world: zero exclusion, zero carbon, zero poverty.

To achieve this mission, Acted relies on an ecosystem of complementary sister organisations:

- OXUS, our social impact microfinance network,
- **IMPACT Initiatives**, which provides data and analysis to guide international aid,
- **Convergences**, a platform for mobilising the public, private and civil society sectors,
- as well as three representative offices in the United Kingdom, the United States and Canada.

Together, we share the same ambition: to act today and invest for tomorrow.

Through its CCCM (Camp Coordination and Camp Management) approach, Acted develops flexible and adapted camp management models that strengthen coordination between humanitarian actors, ensure equitable access to basic services and guarantee the dignity of displaced persons.

GOCA

Acted has designed the GOCA participatory tool to help build the capacity of local civil society organisations. This tool helps to identify their priorities, structure appropriate development plans and promote their institutional autonomy.

THRIVE

The THRIVE programme aims to restore ecosystems, promote sustainable livelihoods and strengthen social cohesion in vulnerable agro-pastoral areas. By integrating the environment, the local economy and community dialogue, THRIVE is helping to build resilience in the face of climatic and socio-economic shocks.

3ZERO HOUSES

Launched by Acted and its partners, the 3ZERO House is a collaborative space dedicated to young people and local innovation. It supports the new generation of agents of change committed to a world of zero exclusion, zero carbon and zero poverty, by offering them a place for training, experimentation and networking.

AGORA

AGORA is a joint approach between Acted and IMPACT Initiatives, rooted in local areas and local knowledge, to better support people in crisis situations.

ZOOM ON SOME MAJOR EMERGENCIES

Gaza

Acted significantly expanded its emergency response in the Gaza Strip (Occupied Palestinian Territory), a complex context where it provided direct assistance in the sectors of food security, water, hygiene and sanitation, shelter, protection and site management.

Acted provided essential data to improve operational planning and efforts to scale up operations.

Acted deployed its AGORA methodology in 8 neighbourhoods in collaboration with UN agencies, Clusters and local and international NGOs, to improve community engagement of response actors.

Lebanon

In response to the displacement of around 1.2 million people fleeing the armed conflict, Acted focused its efforts in particular on Beirut and Mount Lebanon.

The initial response gave priority to covering basic needs as well as light infrastructure work to improve access to drinking water, sanitation and decent shelter in host communities and collective sites.

After the ceasefire, Acted adapted its intervention to meet the needs of returning refugees, while continuing to support those who were still displaced.

Mayotte

A few days after Cyclone Chido hit Mayotte, France, Acted's emergency response team launched relief operations, concentrating its efforts on the worst-hit areas of Petite Terre and Grande Terre despite difficulties with access and the supply chain.

By the end of December, Acted was serving 1,300 meals a day in eight kitchens, planning the distribution of emergency shelters, creating temporary safe spaces for education and supporting economic recovery through grants to micro and small businesses.

Small-scale country-led responses

Throughout the year, Acted also responded to localised shocks through rapid response mechanisms in countries such as Burkina Faso, Chad, CAR, DRC, Ethiopia, Haiti, Niger, Somalia and Ukraine.

It has also responded to extreme weather events (floods in the DRC and the Republic of Congo, Armenia and Burkina Faso), health crises (cholera in Yemen), and displacement caused by armed violence and conflict (Haiti).

In 2024, Acted implemented a new global Programme Quality Review (PQR) process. The objective of the PQR is to take a broader perspective, going beyond the review of individual projects, to assess the quality of Acted's overall programme strategy in each country of operation and the impact we have on the communities we serve. To this end, Acted has developed a tool – the Quality Markers (QM)– to enable field missions to objectively assess and measure the quality of their programming in six key areas:

- Context
- Results
- Accountability and Participation
- Partnerships and Coordination
- Capitalisation
- 3ZERO

The tool has been structured to reflect the six standard evaluation criteria developed by the Development Assistance Committee (DAC) of the Organisation for Economic Cooperation and Development (OECD): Relevance, Coherence, Efficiency, Effectiveness, Sustainability and Impact. Each mission organised a PQR workshop, attended by senior programme and coordination staff, to review the quality marker tool. Once the QRP process is complete, the QM tool generates a score per mission for each of the six quality markers and an overall score out of 90.

The tool was rolled out in May 2024, with each participating country submitting its QRP scores to Acted headquarters by October 2024. This enabled, for the first time, a comprehensive analysis of the quality of Acted's programme, including in-depth insights into the best and worst performing missions, as well as a thematic analysis of the six core areas analysed through the QM tool. Each mission has developed its own Quality Action Plan (QAP) based on the results of their PQR, which will be monitored throughout 2025.

ASSOCIATIVE GOVERNANCE

The General Assembly is Acted's governing body. The members meet annually to approve the Association's financial and report, deal with important issues and report on the past year. It may also meet in the form of an Extraordinary General Meeting.

The Board of Directors is composed of directors elected for three years by the General Meeting; it oversees the Association's main strategic and development orientations, approves policies and the Code of Conduct, the annual budget, the operational scope - and in particular the opening and closing of country missions - closes the accounts, and supervises overall legal compliance. It meets at least once every three months.

The Bureau, which reports to the Board of Directors and meets monthly, oversees the day-to-day management, monitoring, evaluation and analysis of risks, approves key decisions relating to organisational risks, takes administrative decisions relating to operations, examines policies and the Code of Conduct in advance and approves memberships.

The Committees of the Board of Directors are responsible for monitoring specific risks and report to the Board once a year:

- The Risk & Audit Committee;
- The Safety and Security Committee;
- The Remuneration Committee;
- The Safequarding and Compliance
- Committee with the Code of Conduct;
- The Zero Carbon Committee.

The 'Don en confiance' Charter Committee: As a donation-collecting association carrying out missions of general interest, and in accordance with its policies and Articles of Association, Acted is committed to respecting the principles of transparency, rigorous and disinterested management and the efficient use of resources.

PRINCIPLE OF TRANSPARENCY

Acted is fully committed to demonstrating accountability and to its beneficiaries, transparency partners and donors. The organisation ensures that information relating to the allocation and management of its financial resources is accessible. It also ensures that it has all the necessary tools to guarantee rigorous management and optimal operation.

Acted's activities are conducted in accordance with the highest standards of transparency. Robust internal control systems make it possible to monitor and verify each stage of the operational processes. These systems are based on the essential principles of segregation of duties, double validation, competitive bidding, value for money and traceability, in accordance with the organisation's internal procedures.

Acted applies a zero-tolerance policy towards corruption and fraud. To this end, an internal, confidential and independent complaints system, accessible via

www.transparency.acted.org, is used to report fraud and abuse. This mechanism is managed by the Transparency, Compliance & Investigations (TCI) department at Acted headquarters, which oversees the investigation process for any credible suspicions. Acted's conflict of interest policy also aims to strengthen prevention, encourage early detection and implement appropriate sanctions.

Since its creation in 1993, Acted has presented its accounts on an annual basis. Since 1997, the annual accounts have been audited and certified without reservation by an auditor, the firm PKF Arsilon.

The auditors' report, which contains their opinion and assessments, is presented with the annual accounts and is available on the association's website : https://www.acted.org/. Acted's systems and activities in the countries in which it operates are also audited by its donors or by independent audit firms specifically mandated at both head office and country level.

In 2024, Acted facilitated **323** external audits of its operations, covering almost 65% of all its projects. Acted's TCI teams also carried out 39 internal audit missions in 2024 to help improve the organisation's operations.

ZOOM ON OUR COMMITMENTS TO THE CLIMATE AND THE ENVIRONMENT

With its triple mandate as a humanitarian, development and environmental organisation, and in the face of the global climate crisis, Acted supports communities displaced by floods, droughts and conflicts exacerbated by environmental degradation. However, the organisation recognises the environmental cost of its own operations: air travel, fossilfuelled vehicles and energy consumption in crisis zones all leave a carbon footprint.

As part of its 2021-2025 green strategy, Acted has committed to reducing its carbon footprint by 30% by 2025 and by 50% by 2030. At the same time, Acted is significantly strengthening its climate and environmental programmes, aiming for these initiatives to represent at least 25% of its entire project portfolio by 2025.

In 2024, Acted recorded a carbon footprint of 98,457 tCO2, with a 28% decrease in emissions per unit of revenue (kg. $CO2/K \in$), and an overall increase of 6% compared to its 2021 baseline. This increase is attributed not to operational expansion or inefficiency, but to improved data collection and reporting practices. Emissions from back-office

operations have decreased, with energy consumption down by 9% and travel-related emissions reduced by 27%.

The main initiatives to reduce emissions are as follows:

- The solarisation of local offices and the construction or refurbishment of sustainable infrastructures
- Purchasing and using hybrid vehicles
- Reducing dependence on air transport

These efforts reflect Acted's firm commitment to 'walking the talk' when it comes to climate and environmental responsibility.

ZOOM ON THE DECARBONISATION STRATEGY

Building on its Green Strategy 2021-2025, Acted has developed a comprehensive decarbonisation roadmap that sets out a clear and measurable commitment to reducing greenhouse gas (GHG) emissions across its business. Acted's decarbonisation plan sets a clear and ambitious target: a 50% reduction in its greenhouse gas emissions by 2030, using 2021 as the baseline year.

To achieve this goal, Acted will focus on four priority areas through a series of quantified and actionable measures:

- **Purchasing**: Reduce emissions from food and nonfood products by targeting high-emission products such as rice, canned meat and hygiene kits. A green procurement policy will guide the transition to more sustainable sourcing practices. These actions could reduce emissions by 10,000 tCO2e.
- Construction: Promoting bioclimatic design and giving priority to low-carbon or recycled building materials. These efforts should reduce emissions by 1,000 to 1,400 tCO2e through improved choice of materials and design standards.
- Energy: Reduce energy consumption through behaviour change initiatives and by investing in solar energy where possible. Together, these actions could reduce emissions by 1,400 tCO2e.
- **Transport**: Reducing reliance on air travel, encouraging local sourcing and reducing indirect flights. These measures aim to reduce emissions by around 180 tCO2e.

The Towards Net Zero advisory committee, launched by Acted in 2023, is made up of professionals to **support Acted in its decarbonisation strategy** and in better integrating climate issues into its programmes.

Operating costs for the 2024 financial year

Operating costs include expenses relating to the central functions of the organisation incurred at head office or elsewhere that are not directly linked to a particular project, which are considered indirect costs. Approximately half of these costs are devoted to salaries and social security charges for the administrative, financial, logistics, grant monitoring, internal audit and general management departments of the association. This item also includes external charges (e.g. rents, fees) and foreign exchange losses incurred during the financial year (excluding foreign exchange losses on financing contracts).

Their breakdown in 2024 is as follows:

- Staff costs (including taxes): €11,734,862
- Exchange losses and other financial charges: €2,316,051
- Other operating costs (rent, fees, interest, depreciation, etc.): €7,598,615

Reserve policy

The aim of Acted's reserve policy is twofold:

- To be in a position to deal with unforeseen events, by maintaining a minimum balance on the accounts of headquarters and missions (allowing in particular for the coverage of salaries, evacuation costs, security and short-term operating expenses).
- To be able to achieve the organisation's long-term objectives by maintaining a reserve to meet the needs of humanitarian emergency response and cash collection delays, to finance internal medium-term investments and to develop the capacity to invest in innovative entities and projects as part of the 3ZERO strategy.

Acted's associative bonds

As part of its strategy to diversify its financial resources, Acted has played a pioneering role in France since 2012 by issuing Associative Securities to gualified investors with a social impact (last-ranking debt in accordance with Article L.239-9 of the Monetary and Financial Code, repayable at the issuer's initiative). These securities amount to €13,080,000 (Acted redeemed them between 2023 and 2024) and are recorded in the association's balance sheet under Other equity. These bonds have been raised through four fundraising rounds since 2017, the last of which, for €9,000,000 at a fixed rate of 2.5%, was subscribed by five entities in December 2021. Acted repaid more than €5.5 million in Associative Securities between 2017 and 2024.
